The burial is scheduled for 2:00 p.m. following the services.

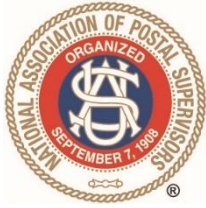
Unfortunately, due to the current COVID pandemic, attendees for Hayes' funeral and memorial service is limited to 25 and by invitation only.
