This letter is in further reference to the Postal Service's previous correspondence regarding the partnership with the General Services Administration (GSA) and Federal Bureau of Investigation (FBI) to provide various biometric services. The most recent notice was dated September 8 (enclosed).

As previously informed, the Postal Service deployed new technology, called the Electronic Biometric Identity Services (EBIS), which consolidated biometric capture, in-person proofing, and personal identity verification (PIV) transactions into one platform. The various services are being incorporated into EBIS in phases. The most recent update replaced the laptops currently in use with new Enterprise Biometric Identity Services (EBIS) equipment in the existing FBI Identity History Summary Check (IdHSC) fingerprinting sites.

The Little River Branch Post Office in Miami, Florida, has been removed from the list and replaced with the Deerfield Beach Post Office, 212 E Hillsboro Blvd, Deerfield Beach, FL.

This letter is in further reference to the notice dated February 7 (enclosed), regarding the Postal Service's partnership with the General Services Administration (GSA) and Federal Bureau of Investigation (FBI) to provide various biometric services. The Postal Service is expanding this program to 71 additional sites.

As previously informed, the Postal Service deployed new technology, called the Electronic Biometric Identity Services (EBIS), which consolidated biometric capture, in-person proofing, and personal identity verification (PIV) transactions into one platform. The various services are planned to be incorporated into EBIS in phases. The recent update replaced the laptops currently in use with new Enterprise Biometric Identity Services (EBIS) equipment in the existing FBI Identity History Summary Check (IdHSC) fingerprinting sites.

Enclosed is a list of the 71 FBI IdHSC sites to receive the new EBIS devices and a copy of the Retail Service Talk, Enterprise Biometric Identity Services (EBIS). Deployment, installation and training of the new devices will take place throughout the month of September and the equipment is tentatively expected to be ready for use by September 30.
