NAPS COVID-19 Communication

May 18-24, 2020

To date, there have been a total of 2,713 COVID-19 confirmed cases in the Postal Service. Currently, 4,718 postal employees are in quarantine, while 18,981 postal employees have returned to work.

Due to the COVID-19 pandemic, on April 8, 2020 NAPS requested from Postmaster General Megan Brennan hazard pay for EAS and additional pay for exempt EAS per ELM 434.143. The USPS responded to NAPS in a letter dated May 20, 2020. The Postal Service denied NAPS' request for hazard pay, but temporarily modified the applicable pay provision, ELM 434.143, allowing Field EAS managers to receive additional pay due to an increase in absences related to COVID-19. This additional pay provision is effective from May 23 to July 17, 2020. Please visit the NAPS website Bulletin Board section and view Board Memo 033-2020 to view the actual USPS response.
