To date, there have been a total of 4,613 COVID-19 confirmed cases in the Postal Service. Currently, 5,534 postal employees are in quarantine, while 26,493 postal employees have returned to work.

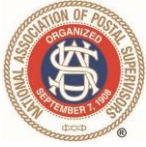
