This is in further reference to the Postal Service's July 17, 2023 correspondence (enclosed) concerning the establishment of Sorting and Delivery Centers (S&DCs). The purpose of establishing S&DCs is to reduce transportation and mail handling costs as well as provide postal customers with additional services. S&DCs will allow for easier standardization and management of operations will have improved building and operating conditions for employees.

The Postal Service originally scheduled the move of the Asheville – London Road Carrier Annex located at 37 London Road, Asheville, NC 28803 for February 2024. However, the Asheville – London RD Carrier Annex did not move. Instead, the Asheville – Grace Station located at 725 Merrimon Avenue, Asheville, NC 28804 will move into the Asheville, North Carolina S&DC on May 4, 2024:
