The Postal Service is continuing its implementation of the Plant Ranking and Management Staffing Criteria for Mail Processing Facilities.

There are several jobs that are no longer earned under the Plant Ranking and Management Staffing Criteria. To minimize the potential for employee impacts, all authorized staffing for the following jobs will be removed effective March 23, 2024:

Employees will not be immediately impacted by this change. Employees will be placed in a nonauthorized status (NAU). Employees will be repositioned into authorized vacancies as they become available. If an employee has not been repositioned when the facility transitions to a Regional Processing and Distribution Center (RPDC) or Local Processing Center (LPC) and the staffing criteria is applied, the employee may be affected by a reduction in force (RIF) at that time.
