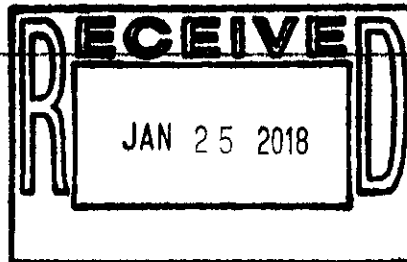

As a matter of general interest, the Postal Service intends to establish dual casing (2 in 1 casing) in certain delivery units in each Area.
