This is in further reference to the Postal Service's October 31, 2023 correspondence (enclosed) concerning the establishment of Sorting and Delivery Centers (S&DCs). The purpose of establishing S&DCs is to reduce transportation and mail handling costs as well as provide postal customers with additional services. S&DCs will allow for easier standardization and management of operations will have improved building and operating conditions for employees.

This notice is to provide further updated information on the sites scheduled for conversion into S&DCs planned to launch on June 1, 2024.

The Postal Service originally scheduled the move of the Seattle – North City Annex into the Everett, Washington S&DC, however, this annex will not be moving. The Postal Service will move the operations within zip codes 98036, 98037, and 98087 for the Lynnwood – Main Office into the Everett, Washington S&DC:
