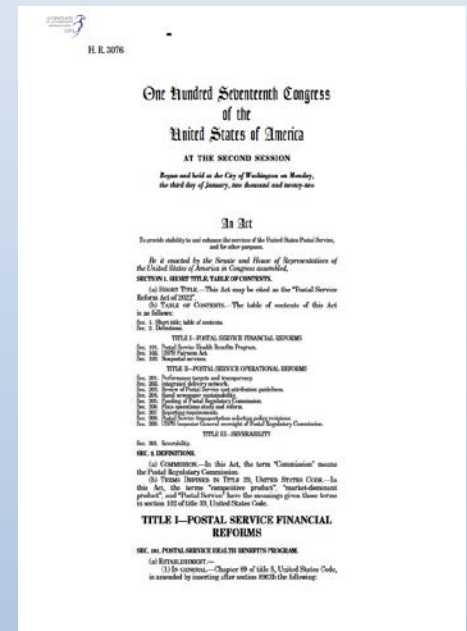

Thank you for HR 3076

- Saves USPS \$50 billion over next the decade
- Repeals unfair retiree health prefunding
- Reduces USPS long-term health liability
- Promotes infrastructure investment
- Protects 6-day mail delivery through integrated network
- Ensures transparency thru online delivery performance portal





Postal Supervisors, Managers & Postmasters Need Fairness

- US Court of Appeals Agrees (2022): 3-0, USPS violated statutory consultation provision
- FMCS Fact-Finding Panel (2021) 3-0, USPS ignored law and made recommendations that were summarily rejected by USPS
- HR 1623 would prevent unnecessary, protracted and costly litigation, and ensure fairness
 - FMCS findings and recommendations would be binding
 - Establish reasonable timetable for consultative process over EAS pay and benefits



Postal Managers Need It!

- More than 5,000 postal managers are denied MSPB appeal rights
 - Most work in USPS HQ positions
- These managers forced to rely an unfair internal USPS review system
- H.R. 1624 would extend MSPB equity to all EAS level postal employees



USPS Reform

HR 3077, Postal Improvement Act

- Includes text of HR 1623 and HR 1624
- Restores Delivery Standard of 2-3 Days
- Funds modernization of postal delivery fleet
- Standardizes Address Block and Bar Codes on Absentee Ballots

- Board of Governors are nominated by President and confirmed by the Senate
- 1 current vacancy
- 1 governor in “holdover” year
- NAPS urges prompt Senate confirmation of Daniel Tangherlini and Derek Kan
- Confirmation Hearing on Thursday, March 31

Social Security Equity



- Social Security system discriminates against CSRS retirees
- Windfall Elimination Provision reduces the Social Security benefits CSRS annuitants
- Government Pension Offset reduces Social Security benefits of surviving spouses of CSRS annuitants
- HR 82 & S. 1302 would repeal WEP & GPO
