As a matter of general interest, the Postal Service plans to insource the handling of the maintenance for the Bio-Detection System (BDS).

The BDS collects air samples from mail canceling equipment on a continuous cycle as incoming mail is being processed. The Postal Service has been using this machine to test for biohazards in the mail system since 2001 and Northrop Grumman has performed the maintenance on the machines since that time. The insourcing of the maintenance for the BDS is anticipated to allow the Postal Service better control of the BDS program and provide for immediate on-site support.

In order to insource the work, it will require Postal maintenance craft employees to receive training on the handling and maintenance of the BDS. It is anticipated that training of bargaining unit employees will begin in September.

Enclosed on compact disc is a list of the 150 BDS sites.
