Board Memo 045-2023: Final Report on the Mercury Spill at Lake Michigan Post Office and Detroit NDC

Executive Board,

Below is the final report on the mercury spill that occurred May 15th at the Lake Michigan Post Office and Detroit NDC locations from Tony Cole, Manager of Emergency Preparedness.

Situation Final Update: After being cleared yesterday afternoon, the Lake and Farwell Post Offices reopen today (Thursday, May 25, 2023). Clearance letters for both facilities have been supplied to the Michigan 2 District. WSP, in coordination with Michigan 2 Leadership, continue to document mail pieces that will be sent for destruction at Lake PO. Storage sheds are being supplied by contractors for disposal items; estimated 2 weeks for waste to be processed.
