Board Memo 048-2023: TACS/eRMS System Outage June 6 through June 8

## **Executive Board,**

Below is an update from USPS regarding an outage of the TACS/eRMS system. The outage will run from June 6 through June 8.

The Postal Service is decommissioning one of the seven instances of the Time and Attendance System (TACS) and Enterprise Resource Management System (TACS/eRMS). This will result in shifting data from TACS/eRMS11 for the former Pacific Area to either TACS/eRMS10 or TACS/eRMS03.

There will be an outage for instances TACS/eRMS03, TACS/eRMS10 and TACS/eRMS11, beginning on Tuesday, June 6, at 03:00 (3 AM Central Time) and it is anticipated to be available at approximately 03:00 (3 AM Central Time) on Thursday, June 8.

Hyper Electronic Badge Readers (HEBR) and other clock ring devices will continue to hold clock rings during this outage and will resume posting/processing after the outage.

TACS11 clock rings will post to either TACS10 or TACS03 as applicable.

The Interactive Voice Response (IVR) and Enterprise Leave Request Application (eLRA) systems will not be operational during this outage for employees assigned within TACS/eRMS11, TACS/eRMS10 and TACS/eRMS03 to submit leave requests. These systems will remain available to employees assigned to other TACS instances.
