NAPS COVID-19 Communication

July 6, to August 2, 2020

To date, there have been a total of 4,217 COVID-19 confirmed cases in the Postal Service. Currently, 8,769 postal employees are in quarantine, while 31,209 postal employees have returned to work.

In the last NAPS COVID-19 Communication issue, NAPS reported there were increases in COVID-19 cases and hospitalizations across many states. Unfortunately, as of this issue, more states have reported a spike in COVID cases. NAPS members should not underestimate the affects this pandemic can have on their health or the health of their families and with whom they work. NAPS encourages the practice of social distancing and wearing of masks or face coverings during this pandemic.
