SUBJECT: Organizational Structure - District Staff Alignments

This is a follow up to the August 7, 2020, Organizational Restructure memorandum. The next step in our progress of moving to a successful future state is realignment of district staff.

District alignments will mirror the changes implemented for the areas. Support functions will temporarily maintain the seven areas and 67 districts alignment while centralized under the designated Headquarters function. Future alignments to the new Operations areas and regions will be determined, communicated and implemented at a later date. Reporting relationship changes for District functions are as follows:

- Human Resources (HR)
 - o District HR Managers will report to Area HR under the Vice President (VP), Employee Resource Management.
 - o District Labor Relations Managers will report to Area Labor Relations under the VP, Labor Relations.
- Finance and Budget
 - o District Finance Managers will report to Area Controllers under VP, Finance and Strategy.

The Logistics and Processing Operations function will now have two regions and 12 divisions. All Plant Managers will report to their respective division under the Eastern or Western VP Regional Processing Operations. These divisions will provide mail processing support to Area and Districts within the Retail and Delivery function. A breakdown of the processing alignment is attached for reference.

The Managers of Transportation Networks within all processing and distribution facilities will report into the new regional organization under the VP, Logistics. Mirroring the two regions and 12 divisions for Mail Processing, Logistics will support the country by providing efficient transportation services to plants and retail facilities.

Marketing, Operations Program Support, and Information Systems will continue to report to the District Manager for now. This work is under evaluation and determinations on how to properly align resources within the functions will be made in the near future.

These initial changes to reporting relationships do not result in employee impacts that would require a reduction-in-force (RIF). Pay-for-Performance plans will remain unchanged for fiscal year (FY) 2020. Adjustments for FY2021 will be announced at a later date.

The leadership team understands that these changes are significant and can cause concern. We are being deliberate with decisions and are working progressively towards an organization that supports our mission and strategy in an efficient and effective manner.

During this time of organizational change, stay focused on our critical mission and deliver for our customers.


