This is in reference to our October 9, 2019 notification (attached) concerning the Postal Service's plan to conduct a job analysis of the Supervisor Customer Services (occupation code 2310-0022) and Supervisor Distribution Operations (occupation code 2315-0066) positions. This initiative will resume in the coming weeks and has been expanded to include Supervisor Maintenance Operations (occupation code 2355-0010) positions. The intent of this analysis is to collect job information to support HR-related initiatives, such as updates to job descriptions, training content, and assessments.

SUBJECT: Supervisor Operational Initiative

As part of a comprehensive initiative to review the role of our front-line supervisors, we will be continuing our supervisor job analysis. Results of the effort will inform the process and tools for hiring, onboarding, and training supervisors. This work will have a significant impact on the future of the Postal Service in that the supervisor role is a critical position in our daily operations and the engagement of our employees.

In the coming weeks, a sample of supervisors (Customer Service, Distribution, and Maintenance) will be emailed a survey asking about work activities and the competencies needed to perform their jobs. It's necessary that we have support from all levels of field leadership to encourage supervisors to complete the survey. The survey will take approximately 30-40 minutes. As always, participation in this review will in no way affect the employment status or opportunities of the current job incumbents. The data collected will remain strictly confidential and will be used for research purposes only.

With the continued impact of COVID-19 and the approach of peak hiring, we recognize that you have a lot on your plates. However, your communication and reinforcement of the supervisor initiative within your areas and districts are fundamental to its success and the future of the Postal Service.
