Dear Ivan:

This is in response to your June 6 correspondence and allegations that the Postal Service failed to consult nor communicate with NAPS, at any time, of plans to apply Reduction-in-Force (RIF) procedures within the Logistics function. Your allegations are not accurate.

The Postal Service notified you, by written correspondence on February 7 (enclosed), of its proposal to revise non-bargaining positions within Logistics to include modification of staffing criteria. The correspondence specifically references a RIF, by stating "Implementation of these changes as proposed may result in employee impacts requiring a reduction in force to be administered" and that changes were proposed, pursuant to Title 39 U.S. Code § 1004.

I messaged you on February 8 and referenced the February 7 correspondence, to inquire of your availability for a meeting and informing that the Postal Service still intended to participate with NAPS in helping employees, impacted by RIF, in securing landing spots as we have in the past. I messaged you on March 10 and reminded you of the February 7 correspondence and suggested that we meet on the Logistics staffing proposal and that I assumed that you would have questions concerning it. We did not receive requests for a briefing, feedback nor recommendations to the proposal during the prescribed 60-day consultation period and therefore sent a decision letter to your attention on April 11 (enclosed) advising that we intended to implement the proposal.

We did not hear from you until May 3 inquiring of whether employees were informed of a RIF in the Logistics function. We responded that employees were not informed of a RIF but it would be forthcoming. We provided a RIF timeline to you on May 30.

The Postal Service will continue with implementation of the RIF in Logistics consistent with the RIF timeline that was provided to you on May 30. This includes two rounds of posting periods within the Logistics Division Competitive areas for employees prior to the RIF effective date. We will also continue with our practice of providing you a list of RIF-impacted employees, once employees are notified, and update you throughout the RIF Notice Period on the status of remaining impacted employees.
