Dear XXXX:

This is in further reference to the Postal Service's July 29, 2022 correspondence (enclosed) concerning establishment of Sorting and Delivery Centers (S&DCs). The purpose of establishing S&DCs is to reduce transportation and mail handling costs as well as provide postal customers with additional services. S&DCs will allow for easier standardization and management of operations will have improved building and operating conditions for employees.

The Postal Service is leasing a new facility, beginning in January 2024 with the intent of establishing a S&DC in Pompano Beach, Florida. The facility is located at 3150 NW 33<sup>rd</sup> Street, Pompano Beach, Florida 33064. Once occupied, the Postal Service intends to move all delivery routes from the five facilities within the Pompano Beach installation (below) to the S&DC. The facilities and the retail operations will remain and will be consistent with other spoke facilities.

The movement of operations will not occur prior to January 2024. The Pompano Beach – Tropical Reef Station will be the first facility scheduled for its operations to move to the Pompano Beach S&DC. We will provide a schedule for each planned move once it's known.
