#### New Castle S&DC Update

#### Date: 11/6/2024

The Postal Service is creating a network of Sorting and Delivery Centers (S&DC) across the nation to move mail and packages more efficiently. This means there will be fewer trips needed to transport mail between facilities, which is not only more cost effective, it also reduces the Postal Service's carbon footprint. These changes are part of Delivering for America, the Postal Service's 10 year plan that is designed to achieve financial sustainability and service excellence.

S&DCs are currently being implemented nationwide. They will feature upgraded bathrooms, breakrooms and color schemes. Workroom floor and parking lot layouts will be redesigned. All of these improvements are aimed at giving employees a better workplace and enhancing productivity. Employees will be provided with upgraded equipment including new carrier cases, new letter and flat distribution cases, and ergonomic floor mats. There will also be new technology, like small delivery unit sorters (SDUS) and other equipment.

With all these upgrades, there may be some growing pains. Here are some items that will be worked on this week:

- Lockers will be numbered and assigned soon- the men's room is already done. If you need a locker assigned, please get with Raleigh.
- Construction by the dock and the cases being built in the back- Please try to stay out of those areas
- Our first wave of cases are almost done and as we get full cases built we will be replacing everyone's cases one at a time.
- Restroom areas are complete also the new fridge and ice maker are installed in the break room, ready to use.

Additionally, there will be a lot of changes that will be happening in the coming weeks with the S&DC's. These changes include:

Carrier entrance doors are being removed at the moment and replaced with brand new ones.

These are some big changes. As we make our operations more efficient and modernized the organization, we are also sustaining and strengthening career opportunities for Postal Service employees, and improving how we serve the nation.

Facilities and our team was not provided information on this deviation from the approved phased parking lot work, that provided the appropriate parking spots.
- Jackson MI SDC:
  - Status of charging stations: Provided district and site management with SWI for proper utilization procedures
- Flint MI SDC:
  - Status of rolling door and building security: Facilities will be on site early next week to work on a solution for the garage access system as this was supposed to be in the scope of work.
  - Status of ventilation system in underground parking garage: The parking garage's ventilation system is controlled by a CO sensor, so the system will be turned on when CO reaches the setting level. It doesn't run constantly. There were no reported issues from the facility or tickets opened, but with this inquiry the contractor is coordinating the HVAC contractor to inspect the system and will look into alternatives to ease the concerns if needed
- Kilmer NJ SDC:
  - Status of future state parking lot: Currently facilities is projected to have sufficient parking for the February carrier moves. Further communication with facilities pending. Any changes will be communicated as soon as possible
