As a matter of general interest, the Postal Service intends to deploy a new package sorting machine, the Small Delivery Unit Sorter (SDUS), to various locations throughout the country.

The SDUS will be housed in delivery units and is designed to sort packages to the carrier route level. Currently, a single SDUS is operational at the York, Pennsylvania Post Office.

This is in further reference to the Postal Service's June 15 correspondence concerning the establishment of Package Support Annexes (PSAs) (copies enclosed).

The Postal Service plans to deploy modified versions of the SDUS, known as the Single Induction Package Sorter (SIPS), to 42 PSAs and 9 mail processing facilities throughout the country.

The SIPS, in contrast to the SDUS, will be affixed with an Optical Character Recognition (OCR) unit, allowing it to read the text of addresses as opposed to only barcodes. Additionally, preventative maintenance for the SIPS will be performed by maintenance personnel.

Enclosed is a list of sites where the SIPS will be deployed. The SIPS deployment schedule has not yet been finalized and will be provided as soon as it becomes available.
