Dear Brian:

As a matter of general interest, the Postal Service plans to conduct a test concerning providing customers with free packaging tape at select Post Offices.

The test, which is scheduled to occur between July 23 and September 4, will include four different scenarios: (1) no free packaging tape provided; (2) free clear packaging tape provided; (3) free Priority Mail Tape provided; and (4) free clear and Priority Mail Tape provided.

During the test, customers at the test locations will be surveyed to gauge the impact of the packaging tape offerings on customer satisfaction.

We have enclosed a copy of a PowerPoint presentation that identifies the test locations.
