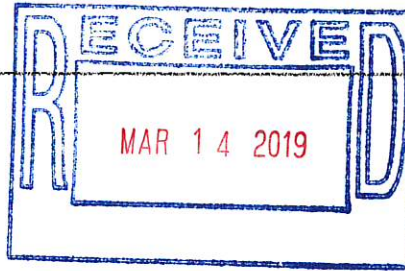

This is in further reference to our December 10, 2018, notice concerning the Postal Service's plan to test In-Office functionality on the Mobile Delivery Device (MDD). The focus of this initiative is to incorporate Intelligent Mail Data Acquisition System (IMDAS) In-Office user software into the MDD.

Testing will be expanded beginning on March 16, in the sixteen locations indicated on the enclosure. Two MDDs will be deployed to each unit to be used in place of the IMDAS. Testing will last approximately two weeks in the subject locations.
