HERO Is Being Retired

In January 2024, the Postal Service launched MyHR, a new human resources website, that centralized all HR information and tools from Blue and LiteBlue.

As we continue to further streamline MyHR as a single location for all HR-related information, **effective August 27, 2024, HERO will be retired.**

Access to current HERO tools and resources will be available from the MyHR homepage allowing you to directly access learning resources, self-development opportunities, and various job aids and support material.

To access MyHR, visit www.LiteBlue.usps.gov ("w-w-w DOT l-i-t-e-b-l-u-e DOT u-s-p-s DOT g-o-v"), and log in with your employee identification number and password, and validate your identity with multifactor authentication.

After selecting the MyHR link, use the search bar, MyHR Apps and other links on the home page to locate training, learning resources and other HR tools.

Employees who elect to take self-development courses may do so voluntarily off the clock. However, training assigned by your manager, permitted by your manager because it is job-related, or training otherwise required must be completed while on the clock.
