This is in further reference to the Postal Service's ongoing correspondence concerning the establishment of Sorting and Delivery Centers (S&DCs). The purpose of establishing S&DCs is to reduce transportation and mail handling costs as well as provide postal customers with additional services. S&DCs will allow for easier standardization and management of operations will have improved building and operating conditions for employees.

This notice is to provide further updated information on the sites previously scheduled for conversion into S&DCs planned to launch in June and September of 2024.
