As a matter of general interest, the Postal Service intends to install WebCam devices in various mail processing facilities to monitor/view mail conditions and the status of processing operations. Additionally, the Postal Service will also leverage existing closed-circuit television (CCTV) cameras, which are maintained and operated by the Inspection Service, in some mail processing facilities for the same purpose.

The visuals captured by the subject WebCams and Inspection Service CCTV cameras will be available to and only accessible by Management, either through livestreams or still frame images. The livestreams will not be recorded and the still frame images will only be available to view for a short period of time before being deleted.

Enclosed is a list of mail processing facilities where WebCam devices will be installed, and Inspection Service CCTV cameras leveraged, for the purpose of monitoring/viewing mail conditions and the status of processing operations.
