Examples of greenhouse gas emissions that are causing climate change include carbon dioxide and methane. These come from using gasoline for driving a car or coal for heating a building, for example. Clearing land and forests can also release carbon dioxide. Landfills for garbage are a major source of methane emissions. Civics 101 Senate Voting Dilemma?

The current United States Senate is made up of 100 members (two Senators per state) are evenly divided Democrats and Republicans (with two Independents that caucus with the Democrats)

Current rules require a 60-member vote to pass major legislation, Build Back Better, Voting Rights, Climate Change, Gun Regulations! In order to pass legislation on a majority vote it takes all 50 votes of the majority party plus the Vice President to break the tie and change the rules so a majority votes can occur. The current Senate has two Senators in the majority party that refuse to vote to change the rules. As a result, recent legislation passed in the House has been stalled in the Senate!

We welcome all postmasters and encourage them to continued membership in NAPS and they are entitled to all the benefits of NAPS members including representation by our NAPS Disciplinary Fund (DDF) provider at no charge!

<u>NAPS California Workplace Climate Surveys</u> are being completed **California 2 and 3 Districts** have completed their climate survey reviews and meetings with district leadership! Several branches are still collecting and reviewing their returned surveys, compiling the data and scheduling meetings with their district management. The goal is to complete the surveys and review process by mid-August. All branches must meet with their local leadership before the information is shared with USPS Area Management and NAPS HQ!

<u>Ethics</u> – All EAS are mandated to follow ethical conduct/procedures when conducting Postal Business. Postal Service is committed to maintaining its reputation as the most trusted government entity through principled decision-making and strong ethical values. All postal employees are required to place loyalty to the Constitution, the laws, and ethical principles above private gain. Section 662.1 of the Postal Service's Employee Labor and Relations Manual states as follows: To ensure that every citizen can have complete confidence in the integrity of the federal government, each federal employee, including each postal employee, must respect and adhere to the principles of ethical conduct set forth in 5 C.F.R. § 2635 [the <u>Standards of Ethical Conduct for Employees of the Executive</u> <u>Branch</u>; .If an EAS is notified to attend a Ethics investigation it is our advice to request a representative and to tell the truth. There is an Adverse Action charge ": *Lack of Candor",* (Always be truthful) which if an employee is found to have lied by the agency, can be grounds for Removal from the Postal Service! *Reference USPS Ethic commitment to ethics page.*
