November Consultative Meeting Minutes Wednesday, November 13, 2019

NAPS is exploring methods to identify newly promoted EAS who are joining the Association.

NAPS is requesting that the current P.S. Form 1187 be modified to include a check-off box to identify newly promoted EAS.

Response: After discussion, NAPS withdrew this item.

NAPS has been made aware that the USPS no longer allows access to the P.S. Form 1187 on the USPS website Forms and Documents section.

NAPS contends that this action violates ELM 911.2 which states:

911.2 Right to Membership

No interference, restraint, coercion, or discrimination to encourage or discourage membership in a labor organization may be affected in the Postal Service.

NAPS contends that the USPS is interfering with potential members having access to the required USPS document needed to participate in the Management Association.

NAPS is requesting that the USPS restore a P.S. Form 1187 accessible on the USPS website Forms and Documents section.

Response: ELM 911.2 Right to Membership details participation and membership in labor organizations. This provision does not apply to NAPS. Additionally, PS Form 1187 does not exist. NAPS Form 1187 is used by NAPS for authorization of dues withholding. The Postal Service does not store non-Postal forms in its repository.

NAPS has been made aware that Transportation supervisors are using IMD scanners to note reasons why a truck may be delayed. Valid reasons could be an accident on the highway, for example. However, one reason that is NOT available is traffic congestion.

NAPS contends that in large cities such as Chicago, New York, and many others, traffic congestion, particularly at certain times of the day, definitely could be an impact to a vehicle arriving late at a plant dock.

NAPS believes this would affect the arrival/dispatch profiles, plus affect trips on time, and have a negative impact on NPA.

NAPS is requesting that there be an update to IMD scanners to include a reason code for traffic congestion.

Response: When a trip is late, PVS drivers are prompted to identify a delay reason to properly document all Inbound or Outbound delays. Choosing the correct delay reason is not only crucial to visibility but is vital for maintaining accurate Transportation records. On September 9, 2019, Traffic / Construction / Detour was added to the current list of delay reasons. This reason code should be used due to congested traffic, construction or a detour along the route.

NAPS has been made aware that EAS assigned to the Cincinnati P&DC are being involuntarily reassigned to the Springdale Processing Facility.

NAPS received a briefing on this project at the 0818 consultative, item 7.

In light of the involuntary reassignment that has now occurred at this processing facility, NAPS would like to see the current staffing package for the Springdale Processing Facility.

Response: Ann Mailloux, Director Organization Design, attended the meeting addressing this item. Springdale is an annex of the Cincinnati P&DC. The current staffing for the Cincinnati P&DC is as follows:
