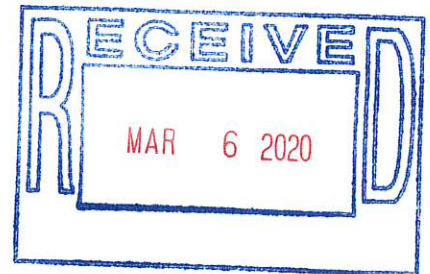

A-2 Travel Per Diem Rates

Effective immediately, the Postal Service will no longer publish annual per diem rates.

Domestic per diem rates for the continental United States (except for Norman, Oklahoma) are available on the GSA website at www.gsa.gov/perdiem.

Domestic per diem rates for the noncontinental United States (Alaska, Hawaii, Puerto Rico, and U.S. possessions) will follow the rate for GSA's high-cost locations. Lunch Equivalent to GSA standard rate deduction
Dinner \$3 less than the GSA standard rate deduction
