As a matter of general interest, the Postal Service is adding a *Scan Prepaid Label* option on Self Service Kiosks (SSKs) in retail units.

This option will allow customers to scan a prepaid label for PC postage or Return Merchandise. Customers will be prompted to select the *Other Services* icon on the SSK to access the *Scan Prepaid Label* option. This scan is the same process as the acceptance SSK label generation.

The prepaid acceptance scan option is scheduled to be available nationwide by the end of December.

Enclosed is a copy of the Retail Service Talk, New Functionality Guide, and Poster.

Self Service Kiosk (SSK) New Functionality - Pre-paid Acceptance Scans

At SSK locations, customers can receive an acceptance scan and receipt for their prepaid mail piece (i.e.; PC postage or Return merchandise label).


The customer accesses the Scan Prepaid Label workflow by selecting 'Scan Prepaid Label' on the Other Services option,

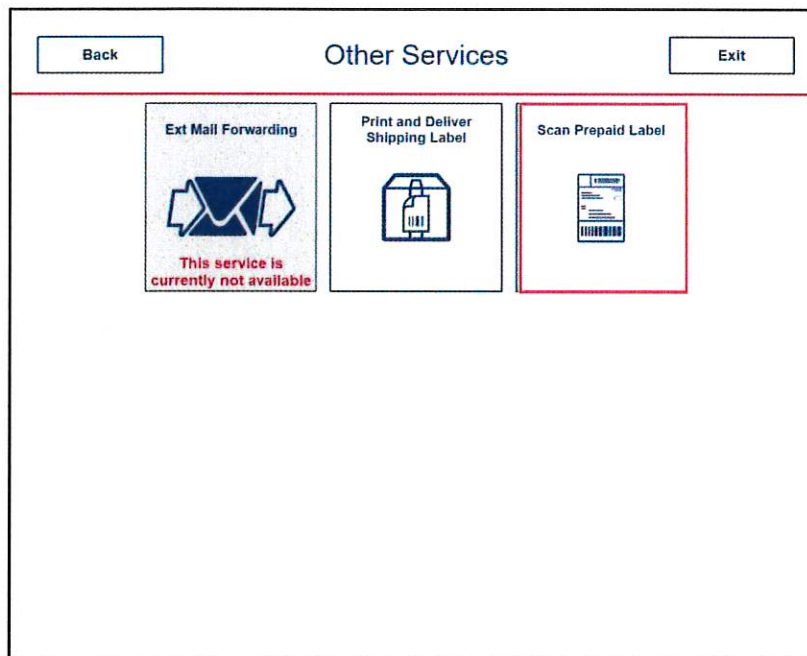
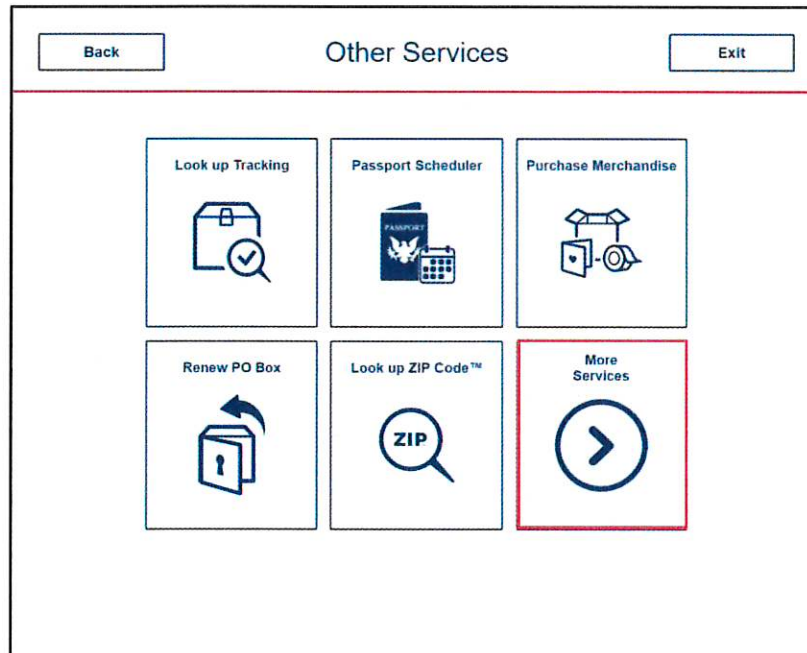
