As a matter of information, the Postal Service has completed the annual Postmaster Fair Labor Standards Act (FLSA) review. The Postmaster FLSA review is performed for Level 18 Postmasters on an annual basis in accordance with the Fair Labor Standards Act (FLSA).

Postmasters are classified as exempt provided they meet certain requirements, including customarily and regularly directing the work of at least two or more other full-time employees or their equivalent (workers who work a combined total of 80 hours per week).
