The Postal Service has reconsidered its November 14, 2018 decision regarding NAPS's request to include among the list of positions eligible for the Supervisor Differential Adjustment (SDA), the Safety Specialist (TL)(EAS-17)(Occupation Code: 0018-0031) position. As you know, that decision advised that the Safety Specialist (TL) did not meet the established criteria for the SDA and a proposal would be sent to NAPS revising the Position Description.

The Postal Service has determined that the position has oversight, including supervisory duties, over activities of two or more full-time equivalent bargaining unit employees. Therefore, this position has been added to the SDA chart. The effective date of this change is March 2, 2019 and a copy of the updated SDA chart is attached.
