Dear Mr. Butts:

As a matter of general interest, the Postal Service has initiated a pilot test entitled *Logical Group Routing* (LGR). LGR is a tool designed to assist supervisors in projecting the number of routes required and appropriate staffing for Sunday package delivery.

Specifically, LGR will utilize historical data and a predictive process to provide improved insight for decision making as it pertains to managing and routing parcel routes. During the test, management will log into the Parcel Delivery Territory Assignment Tool (PDTAT) on the Wednesday prior to a Sunday parcel delivery date and input data based on the previous six weeks of historical package volume. The model will continue to update throughout the remainder of the service week and will provide a projected schedule of parcel routes and number of employees required for Sunday package delivery.

Clerks will scan parcels using the LGR configuration setting on the PASS and ADUS machines and set up their "bullpen" operation based on the number of routes projected. This set up may change every week depending on the volume and workload that Sunday. The MDD application has been updated to allow carriers to select LGR during their login process. They will select their assigned route and load their vehicle based on the loading tool. The MDD scanner will also provide the carrier the best line of travel for parcel delivery.

The LGR pilot test was initially implemented on October 3 in twenty-one sites. However, during the week of October 10, site locations were decreased to three. As we continued to evaluate the usage of the LGR process, the number of test sites were increased to nine locations during the week of October 17. Effective October 24, we have now increased to eleven sites.

Enclosed is a copy of the site locations that were activated/deactivated during the month of October.
