As a matter of general interest, the Postal Service is updating Handbook F-15, *Travel and Relocation*, Appendix A-2, *Travel Per Diem Rates*.

Revisions to Handbook F-15, *Travel and Relocation*, Appendix A-2, *Travel Per Diem Rates* will reflect the new policy guideline on the per diem rate and meal deductions for Norman, Oklahoma. These changes are part of the 2021-2024 National Agreement with the American Postal Workers Union, AFL-CIO (APWU) and go into effect on November 7th.

We have enclosed two copies of the revised Handbook F-15, *Travel and Relocation*, Appendix A-2, *Travel Per Diem Rates*, one with and one without changes identified.
