This letter is in further reference to the Postal Service's previous correspondence regarding the partnership with the General Services Administration (GSA) to provide the biometric capture of fingerprints for the activation of Personal Identification Verification (PIV) cards for newly hired federal personnel. The most recent notice was dated March 9 (enclosed).

Postal Operations personnel will be collecting information by observing PIV transactions in designated offices to evaluate the average time spent on each transaction. This evaluation is to ensure that the office is receiving proper credit for the work being performed during each PIV transaction.

The evaluations will occur between July 27 through August 31 and will observe the three primary types of PIV transactions:

- Identity Verification PIV Enrollment
- PIV Card Activation
- PIV Rekey

Enclosed is the service talk that will be given regarding the evaluation.

This letter is in further reference to the Postal Service's previous correspondence regarding the Postal Service's partnership with the General Services Administration (GSA) to provide the biometric capture of fingerprints for the activation of Personal Identification Verification (PIV) cards for newly hired federal personnel. The most recent notice was dated November 10, 2022 (enclosed).

As previously informed, the GSA has enlisted the Postal Service's assistance with credential verification during the hiring process. The GSA USAccess is a program that provides federal government agencies with identity credential solutions. Retail employees will use the program to enter applicant data for verification processing and PIV card activation.

In April, the Postal Service plans to expand the GSA USAccess program to the following five additional sites listed below by Area, District and Facility:

Retail Service Talk

Government Services Administration (GSA) USAccess Personal Identity Verification (PIV) Credentialing Pilot Expansion

In November 2020, the USPS launched a pilot program in partnership with the Government Services Administration (GSA) USAccess to support Personal Identity Verification (PIV) credentialing services in six (6) Washington, DC region offices. PIV credentialing services help to protect and keep government assets secure, including facilities, computers, and information systems. This is a fundamental responsibility of government employees.

Sales and Service Associates (SSAs) are providing these services by operating GSA PIV equipment at selected USPS retail locations in support of the GSA USAccess Program. The program provides 120 Federal Agencies with identity credential solutions which consists of three primary PIV Card service transactions:

- 1. Identity Verification PIV Enrollment
- 2. PIV Card Activation
- 3. PIV Rekey

USAccess and the USPS have expanded this partnership to additional USPS retail locations nationwide with the service now available in twelve (12) USPS retail locations nationwide.

The USPS is planning to evaluate the various types of PIV transactions in the coming weeks. Operations will be visiting the above retail locations and observing the three (3) different types of PIV transactions. The evaluations will take place at each of the active GSA USAccess sites from July 24 through August 31, 2023.

Managers and supervisors must inform all retail team members of the upcoming review activities. Employees should be instructed to conduct business as usual to ensure an accurate reflection of the transactions. In addition, Personal Identifiable Information (PII) of PIV participants must always be protected, and PII should never be shared with any parties other than active registrars and PIV applicants.
