Dear Mr. Butts:

As a matter of general interest, the Postal Service will be conducting a pilot test entitled, F4 Back Office Pilot. This pilot will take place in 40 USPS delivery units and is designed to improve efficiency in our AM Function 4 operations in an effort to achieve earlier Distribution Up Times (DUTs).

The pilot test will use a daily management system of F4 back-office plays, formerly known as Standard Work Instructions (SWI), for each level of the organization to help streamline F4 distribution and improve DUT. This will be done by focusing on plays such as floor layout, staffing, scheduling, and Gemba walks.

F4 Back Office Pilot will start in April and run for a minimum of 6 weeks.

We have enclosed a copy of a Mandatory Stand Up Talk detailing the pilot and a list of the 40 pilot locations.

Stand-Up Talk: F4 Back Office Play

The success of a delivery operation relies on an effective and efficient mail processing operation. Distribution Up Time (DUT) occurs when all mail types; parcels, flats and letters, are distributed to the carriers. To improve efficiency in our AM Function 4 operations and achieve an earlier DUT, we will be conducting a F4 Back Office Pilot in forty USPS delivery units.

What does this mean?

This pilot will use a daily management system of F4 back-office plays for each level of the organization, to streamline F4 distribution and improve DUT. These plays are focused on:


- Staffing and scheduling
- Floor layout
- Performance management
- · Pre-planning for success
- Daily huddle
- Gemba walk
- Reflection
- Improvement

With package processing being our most labor-intensive operation and our growing business, we will concentrate on package sortation, setup, and working packages first.

Following the back-office play will ensure we maximize our mail processing window. SSDAs, who drive the 24-hour clock and provide on time mail processing, are the key to success.

This pilot will start in April and run for a minimum of 6 weeks.
