Dear Mr. Butts:

This is in further reference to our previous correspondence concerning Sorting and Delivery Centers (S & DCs). As discussed in our July 29 correspondence the purpose of creating S & DCs is to reduce transportation and mail handling costs, as well as provide Postal customers with additional services. S & DCs will allow for easier standardization and management of operations while improving building and operating conditions for employees.
